Subchapter 1: General

- Added definitions to clarify types of child care licenses and license-exempt
- Clarified language around child care license types and how an applicant can select the type of provider they want to be
 - Added out-of-school-time child care program licensing path
 - Provides minimum regulated path for family, friend, and neighbor providers
- Clarified language around ratios, group sizes, and staffing
 - Higher ratio and group size for out-of-school-time programs
- Spelled out the licensing steps, including pre-inspection and inspections and clarified they can only occur during hours of operation
- Added rule to allow license or registration to remain in effect while renewal being processed
- Clarified licensing technical assistance provided by department and partners
- Added ability for providers to propose innovative pilot projects under a provisional license

Subchapter 3: Administrative

- Added new definitions to clarify the difference between student suspension and expulsion
- Combined requirements from several existing rules related to policies and record-keeping, and reorganized for ease of understanding for providers, families, and staff
 - All required policies are listed in one rule and the type of provider needing each set of policies is included
 - Record-keeping rules separated by type of record program, child, staff
- Reorganized existing rules on family rights and department rights related to communication from providers for ease of understanding

Subchapter 4: Safety and Facilities

- Added definitions for clarity, including for safe sleep environments incorporating cradleboards
- Removed requirements for duplicative inspections for commercial buildings (including public schools)
- Clarified and aligned indoor and outdoor space requirements, providing more options and flexibility to meet standards
- Added clarity and consistency to rules around exits, egress, and fire safety
 - Clarifies that apartment buildings can include a home-based child care facility as long as all residential fire code requirements are met by the building
- Aligned swimming safety with Caring for Our Children best practices
- Streamlined transportation safety requirements
- Removed details that were additional burden, unable to be enforced, and not contributing to health and safety of children
 - Examples: no riding the back of trucks, minimum room temperature, washing machine temperature

Subchapter 5: Medical Health

- Added definitions of 'health care provider' to align with MT ARM and MCA, and 'supplement' to distinguish from medication
- Streamlined and removed redundancy in medication management
- Updated 'sick child' rules to reflect best practice
 - Removed some exclusion criteria for illnesses that are not considered contagious, which will help parents and families by not excluding children when unnecessary
 - Aligned with non-exclusion requirements of 2021 HB 702
- Streamlined first aid kit requirements

Subchapter 6: Environmental Health

- Aligned indoor and outdoor air quality with MT ARM for public schools
- Simplified hygiene, laundry, and bathing requirements to focus on goal of maintaining child health rather than prescribing how
- Combined diapering details from several current rules into single rule to clarify and reduce unnecessary requirements
- Simplified food safety rules to make them easier to follow and to focus on the goal of reducing foodborne illness rather than prescribing how to do that

Subchapter 7: Nutrition and Food Service

- Simplified nutrition requirements that align with CACFP
 - Removes requirement for menus to be reviewed by a dietician, which removes a cost for providers
- Updated guidelines for feeding infants and toddlers
 - Adds current best practices related to bottle boiling, how to handle breast milk
- Streamlined requirements for safe seating for infants and toddlers

Subchapter 8: Immunizations

- Added definitions to add detail to exemption types and health care providers, and align vaccination definitions with requirements
- Clarified exemptions for FFNs (no immunization requirements if all children are related) and RCEs (no immunization requirements)
- Added religious exemption option for children
 - Aligns with SB215 and with immunization of school children requirements (ARM 37.114.701)
- Aligned documentation requirements with those used in schools (ARM 37.114.703) and reduces documentation required for school-age children
- Removed immunization requirements for child care staff members
- Balanced family and provider choice by giving home-based provider option to set policies to not accept immunization exemptions

Subchapter 9: Staff Qualifications and Training

- Streamlined qualifications requirement (education, training, other licensing, experience) to accommodate the broad array professionals and program settings
 - Will allow individuals with elementary teacher licenses, or 35 years of experience but no college degree, or a long background in Montessori education, or many other scenarios to be approved in this role
 - This is important to grow the state's child care workforce, which is essential to increase our child care capacity
- Created clear rules around volunteers and decreased requirements for volunteers who are not left unsupervised with children
- Reduced ongoing training burden for FFNs and RCEs, and aligns training requirements with age of children being cared for

Subchapter 10: Background Checks

- Added three offenses to the must-deny list
 - Partner/family member assault that includes a minor
 - Arson
 - Being named perpetrator in substantiated child abuse and neglect report
- Moved two offenses that are not always violent felonies from must-deny list to may-deny list
 - Burglary
 - Prostitution
- Added being named as a perpetrator in a founded report of child abuse or neglect as a may-deny offense (only if there are other may-deny offenses)
- Clarified a household member can remain in home when children in care are not present for offenses pending resolution
- Clarified and distinguished between the process to appeal a denial based on incomplete or inaccurate information versus request for reconsideration based on rehabilitation
 - Ensures due process and fair hearing rights

Subchapter 11: Enforcement

- Added detail and clarity about the process of complaints and investigations
- Clarified each step in the process if a violation is found:
 - Noticing rights for providers
 - Requirements and timeframes for corrective actions and negative licensing actions if violations are not corrected
 - Process for a denial, suspension, revocation or modification of a license if a violation is not corrected
 - Violations that can lead to negative licensing actions
 - Gives timeframes for reapplication for a license or registration after negative action
- Clarified department role and responsibility for addressing unlicensed, illegal care
